**Introducing the New Global Forever stamp**  
*One Price for First-Class Mail International 1-Ounce Letters to  
Anywhere, Worldwide*



**WASHINGTON** — Today, the U.S. Postal Service introduced the *Global* Forever First-Class Mail International stamp. Priced at \$1.10 each and offered in a pane of 20, the *Global* stamp offers a single price for any First-Class Mail International 1-ounce letter to any country in the world. The *Global* stamp also may be used to mail a 2-ounce letter to Canada.

Customers may purchase the stamps at [usps.com/stamps](http://usps.com/stamps), by phone at 800-STAMP24 (800-782-6724) and at Post Offices nationwide.

The stamp showcases the beauty of planet Earth with an artistic rendering — a composite of images created from satellite and 3D computer technology data. In this image, the Atlantic Ocean is flanked by North and South America, Africa and parts of Europe. Art director William J. Gicker selected this depiction of Earth by Italian artist Leonello Calvetti. Greg Breeding designed the stamp.

**Ordering First-Day-of-Issue Postmarks**

Customers have 60 days to obtain the first-day-of-issue postmark by mail. They may purchase new stamps at their local Post Office, at The Postal Store at [usps.com/stamps](http://usps.com/stamps), or by calling 800-STAMP-24. They should affix

the stamps to envelopes of their choice, address the envelopes (to themselves or others), and place them in a larger envelope addressed to:

After applying the first-day-of-issue postmark, the Postal Service will return the envelopes through the mail. There is no charge for the postmark. All orders must be postmarked by March 28, 2013.

### **Ordering First-Day Covers**

The Postal Service also offers first-day covers for new stamp issues and Postal Service stationery items post-marked with the official first-day-of-issue cancellation. **Grand Rapids** — The Okemos Post Office is accepting applications for the position of a Rural Carrier Associate serving a regular route.

Persons interested should apply as soon as possible because this position application **closes on Sunday, July 28, 2013.**

**ALL** applicants must apply online at <http://www.usps.com/employment>. Click on 'Search Jobs' and apply, then insert RCA in the keywords section and Michigan for location. ALL applicants must apply online by the close of the job posting period — 11:59 p.m. CT on Sunday, July 28, 2013. Paper applications will not be accepted.

Applicants must have a valid state driver's license, a safe driving record, and at least two years of documented driving experience.

A Rural Carrier Associate cases, delivers, and collects mail along a prescribed rural route using a vehicle; provides customers on the route with a variety of services.

Candidates, except for individuals performing active military duty, will need to be present for screening activities, including an interview, in the facility location or vicinity.

The salary for a Rural Carrier Associate is \$15.87 an hour. The employee will be required to work Saturdays and weekdays as needed. May include Sundays and holidays. He/she must be available to work assigned tours, scheduled days and must be available to work on short notice.

A written exam will be required.

Qualified applicants must successfully pass a pre-employment drug screening to meet the U.S. Postal Service's requirement to be drug free. Applicants must also be a U.S. citizen or have permanent resident alien status.
